16/36 **PEAKS AND PLAINS HOUSING – PRESENTATION**
(Agenda Item 4)

Nigel Bennett and Laura Astwood from Peaks and Plains Housing Trust were in attendance to present an overview of the work of the work of Peaks and Plains Housing Trust and properties in High Peak.

A presentation covered:

- Properties owned and managed.
- Services provided including repairs, maintenance, adaptations and improvements.
- Contracts with local authorities.
- Trust Link.
- Energy Support.
- Lifelinks.
- Moving towards becoming a housing provider specialising in affordable housing.
- Challenges in developing new homes.
- Funding for development.
- Active Asset Management.
- Rural schemes.
- Other developments.
- High Peak update.
- Employment and training.



Discussion took place on the business plan for the Homes and Communities Agency and total funding gap of £9 million achieved through restructuring, buying an office building and renting out office space.

It was reported that a joint Corporate and Housing Sub-Committee would develop the Housing Revenue Account business plan over the next 12 months. Work at Victoria Park Road, Buxton would start in October. A recent application for planning permission for Macclesfield Old Road, Buxton had been received, which included 5 shared ownership properties. An update on Buxton empty properties would be considered at the next meeting.

HOMELESSNESS PREVENTION EXPENDITURE UPDATE

The Committee received a report on the expenditure of the Homelessness Budget 2016/17 and proposed Second Homes Council Tax allocation for 2016/17.

Discussion took place on:

- Council tax premium paid by those owning second homes and minimum impact on the number of second houses in the Borough.
- 50% premium charged nationally and 90% in Derbyshire.
- Proposed second homes council tax allocation 2016/17 and the need for information on where value had been added.
- Numbers of second homes in High Peak being around the national average.
- Counselling support available.
- Good News Family Care.

RESOLVED:

1. That detailed information on proposed second homes council tax allocation 2016/17 and about Good News Family Care be circulated.
2. That the Executive be recommended to approve the Homelessness Budget distribution for 2016/17 outlined in table 4 of the report, subject to the approval of the Second Homes Council Tax bid;
3. That the Executive be recommended to note the 2016/17 Second Homes Council Tax bid to Derbyshire County Council outlined in table 3 of the report;
4. That the Executive be recommend to approve the use of second homes council tax funding following Derbyshire County Council approval.
