1. Reason for the Report

- 1.1 To ask councillors to consider the admission of Mr John Pritchard, of Elnor Lane, Whaley Bridge as an honorary freeman of the Borough.

4. Detail

- 4.1 Mr Pritchard moved to Whaley Bridge in 1967 and was elected to Whaley Bridge Urban District Council in 1971, becoming a High Peak Borough Councillor in 1976. He has shown great dedication to representing his local community for over 45 years, helping to empower local people and to ensure that they have a voice as recognised by being made an Honorary Townsman of Whaley Bridge in 1997 for his long and distinguished service, which continues to date as a member of the Whaley Bridge Town Council.
- 4.2 Within the Borough Council Mr Pritchard served on a range of committees. He was Chairman of the Environmental Services Committee from 1983-1987, elected Mayor during 1989-90, Executive Member for Community and Social Development from 2003 until 2007 and Chairman of the Council's Audit and Regulatory Committee from 2007 until 2017 and retired as a Borough Councillor in May 2019.
- 4.3 His drive to improve the quality of life for the community goes far beyond his role as an elected councillor as demonstrated by his time given to advise a wide range of organisations including Friends of Whaley Bridge Station, Whaley Bridge Sports Association, Peak District Rural Housing, Derbyshire Association of Local Councils (past Chairman) and Whaley Bridge Amenity Society (past Chairman) to name but a few. He is a person of great integrity and a true public servant in every sense.
- 4.4 It is proposed that a celebration event will be hosted by the Council later in the municipal year when a commemorative scroll and badge will be presented.
