25 **MINUTES OF THE PREVIOUS MEETING**

28 **BUSINESS RATES REVALUATION AND LOCAL DISCRETIONARY RATE RELIEF SCHEME**

The Cabinet considered a report that provided an overview of the updated and new business rate reliefs that had been recently announced by central government, and sought to approve the Council's local discretionary business rate relief policy. The report was considered by the Resources Overview and Scrutiny Panel on 4 October 2017.

Options considered:
