- (3) Notices will be displayed on the premises advising customers that we operate under the Challenge 21 Scheme.

- (1) All escape routes and exits will be kept unobstructed and Fire Safety Notices will be displayed prominently.
- (2) The Premises will comply with Health and Safety legislation.

d) The prevention of public nuisance

- (1) Alcohol cannot be consumed upon the premises.

- (1) The Premises Licence holder shall operate a Challenge 21 policy when the only acceptable forms of identification are recognised photographic identification cards such as driving licence, Forces ID card, passport or any proof of age card that carries the PASS logo.

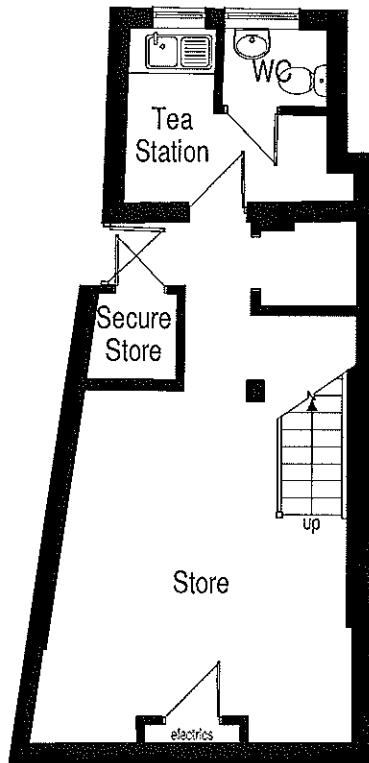

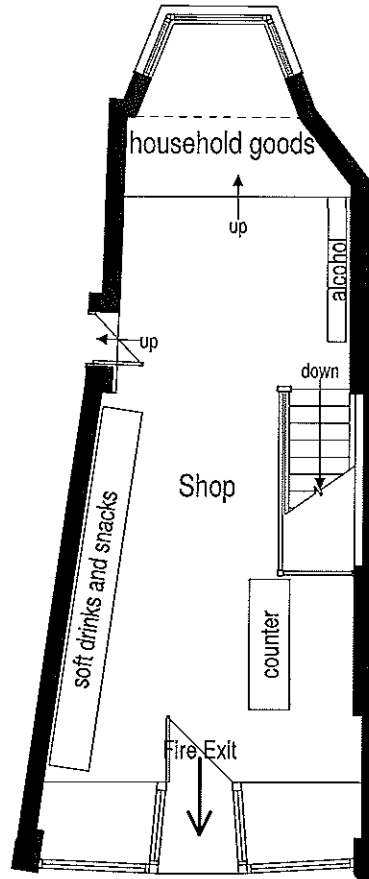

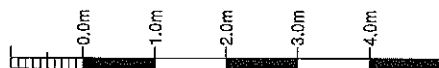
