With regards to the reference in the original evidence submitted by the respondent, that there had been a recent site visit by an officer of Staffordshire Police Firearms and Explosives Team. In particular the comments made by that officer, specifically that the firearms authorisation is not under threat, whatever the outcome of this hearing. Clarity has been sought from the manager of that department who has advised that the suitability of the management of the premises to retain the authority granted by Staffordshire Police in relation to Firearms legislation is to be reviewed in light of the circumstances that have been highlighted in this review application.

Staffordshire Police respectfully request that under Section 100 (A) (4) of the Local Government Act 1972, the email contained in section 29 is to be regarded as exempt information due to the reference made to the Health and Safety Executive. Also the public be excluded from the meeting during the showing of the CCTV footage on the grounds that it involves the likely disclosure of exempt information as defined in Part 1 Schedule 12(A) to the Act.
